					Medical records section.	Medical record is well organized with files stored in shelves. Congested as it was but space is well managed. However, there is no computerized back-up.		
					Consulting rooms.	There are ten consulting rooms in the facility. Seven were assessed and found to be of adequate size. There are examination		

	couches, stethoscopes and three diagnostic sets. Wash hand basin and running taps were seen in all but one consulting room which also had neither a fan nor air-conditioner.
	There were no screens though they claimed to have enough kept in the store.
Treatment room	Treatment room has instrument cabinet, wash hand basin, dressing stool and dressing tray containing necessary equipment.
Accident & emergency.	Emergency tray is properly maintained with all emergency drugs / equipment in place.
	There is alternative water / power source in place. Waste is properly disposed. Firefighting equipment is placed in strategic points in the facility.
Labour room.	Labor room is adequate in size with first and second stages delivery suites. Instruments used for delivery were seen and well kept. However, there is no fan in place and the airconditioner unit and water heater are out of use.
Pharmacy	 The Pharmacy is managed by professionals. Level of drugs was adequate. Air-conditioner was working and a deep freezer is available. DDA cupboard/ register are well maintained.

Dental clinic	Dental clinic has two complete dental units that are fully operational.
Laboratory	The laboratory is adequate in size and is manned by qualified professionals. It is well equipped. They carry out all basic medical investigations. There are sharp instrument waste bins.
Family planning, health education.	Health education, counseling and family planning services are carried out in the facility.
Wards.	➤ The wards are adequate in size and neat. However, there is a particular section of the roof in the maternity ward that is leaking while two officer's wards had no water running.

SUMMARY OF FINDINGS

- 18. In 445 NAF HOSPITAL IKEJA, LAGOS it was observed that the various departments are not computerized.
- 19. **403 EMD NAF MEDICAL CENTER SHASHA**, **LAGOS** was recently moved to a bigger location within the base. The various departments were not computerized.
- 20. In 107 NAF MED CENTRE ONIKAN, LAGOS there is no emergency tray in place.
- 21. In **NAF COMPREHENSIVE SCHOOL MED CENTRE IBADAN** the medical record unit does not have hand cards, tracer cards and no computer backups. There is also no firefighting equipment. The consulting room is neat but no good light source and poorly ventilated. In the pharmacy there is no air conditioning unit and drug reaction registers. In the laboratory department there is no weighing balance, Bunsen burner and microbiological culture media.
